

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to CSAappliance.com and CSA APPLIANCE SALES AND SERVICE and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to CSA APPLIANCE SALES AND SERVICE include CSAappliance.com and CSA APPLIANCE. The CSA APPLIANCE website is a Information and ecommerce site. By using the CSA APPLIANCE website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, CSA APPLIANCE may collect personally identifiable information, such as your:

Use of your Personal Information

Sharing Information with Third Parties
